- 1. Meeting was called to order at 6:35 pm by Nicky Lockwood, President and was held at Jackie Ashley's home while the Marina is being repaired.
- 2. Meeting minutes from December 2022 were approved without changes.
- 3. Treasurer's Report was caught up after some discussion- no change in the account since December in Checking \$584.76 and in Savings 10,152.77 Total Income: 10,737.46
- 4. Edits were made to the letter provided by Kim Kelley and approved to be signed by Jeff Salazar on behalf of the BHA.
- 5. Margo Hill presented about the Boston Harbor Neighborhood Food Project. A Food Bank program that about 60 members of our Community support by providing non perishable food and household items collected 6 times a year. Margo requested a donation of \$250 from BHA to help cover printing costs. Nina asked if their group could distribute info about BHA and our fundraisers. Margo was positive about that request. The Board opted to review our budget and considering the expense before deciding about the donation for one week. Deadline 1/16/23
- 6. Raffle Fundraiser Update: Board Members took tickets to sell and some purchased tickets at the meeting. So far we have sold about 70 tickets, so 1/3rd of the way to the 200 ticket goal. Jeff to post the flier to our website, (other great resulting actions) Bjorn helped post fliers in the neighborhood. Nina helped get tickets, flier and an envelope to the Marina. Kate approved letting folks put a ticket for the Raffle Fundraiser onto their Marina Account. So far \$1510 raised- someone just gave a donation of \$10. Kate recounted the cash-\$1375 & \$100 in checks for the Raffle and \$25 in cash for a membership were given to Michael Deford for deposit.

Old Business: Nina presented a draft sponsorship letter and discussion followed with size of the logos for the donation amounts of \$350 and \$500- she was advised to talk with Alpha Graphics about the ordering of the logos to represent their value.
