- 1. Introductions started with the Welcome from Nicky, then Jeff thanked her for her service with flowers. Also thanked Chris Hamilton with flowers, and Michael after his report.
- 2. New Sheriff- Derek Sanders spoke about department budgets including the shortage of deputies and the resulting overtime budget. Have 34 deputies and need 59.
